

PARTICIPANT AGREEMENT, RELEASE AND ASSUMPTION OF RISK

In consideration of the services of Motocross Vacation, LLC, their agents, owners, officers, volunteers, participants, employees, and all other persons or entities acting in any capacity on their behalf (herein after collectively referred to as "MXV"), I hereby agree to release, indemnify, and discharge MXV, on behalf of myself, my spouse, my children, my heirs, assigns, personal representative and estate as follows:

1. *I acknowledge that renting and driving a motorcycle entails known and unanticipated risks that could result in physical or emotional injury, paralysis, death, or damage to myself, to property, and to third parties. I understand that such risks simply cannot be eliminated without jeopardizing the essential qualities of the activity.*

The risks include, among other things: accidents involving other motorcycles or vehicles; collision with fixed or movable objects; falls from the motorcycle; the negligence of other operators of motor vehicles or myself; weather conditions; my own physical condition; the condition of roads, terrain, motocross track, pit area, or highway and accidents connected with their use; contact with animals and insects.

Furthermore, MXV employees have difficult jobs to perform. They seek safety, but they are not infallible. They might be unaware of a participant's fitness or abilities. They might misjudge the weather, track conditions, or other environmental conditions. They may give incomplete warnings or instructions, and the equipment being used might malfunction.

2. *I expressly agree and promise to accept and assume all of the risks existing in this activity. My participation in this activity is purely voluntary, and I elect to participate in spite of the risks.*

3. *I hereby voluntarily release, forever discharge, and agree to indemnify and hold harmless MXV from any and all claims, demands, or causes of action, which are in any way connected with my participation in this activity or my use of MXV's equipment or facilities, **including any such claims which allege negligent acts or omissions of MXV.***

4. *Should MXV or anyone acting on their behalf, be required to incur attorney's fees and costs to enforce this agreement, I agree to indemnify and hold them harmless for all such fees and costs.*

5. *I certify that I have adequate insurance to cover any injury or damage I may cause or suffer while participating, or else I agree to bear the costs of such injury or damage myself. I further certify that I am willing to assume the risk of any medical or physical condition I may have.*

6. *In the event that I file a lawsuit against MXV, I agree to do so solely in the state of California, and I further agree that the substantive law of California shall apply in that action without regard to the conflict of law rules of that state. I agree that if any portion of this agreement is found to be void or unenforceable, the remaining document shall remain in full force and effect.*

By signing this document, I acknowledge that if anyone is hurt or property is damaged during my participation in this motocross activity, I may be found by a court of law to have waived my right to maintain a lawsuit against MXV on the basis of any claim from which I have released them herein.

I have had sufficient opportunity to read this entire document. I have read and understood it, and I agree to be bound by its terms.
